BANDSTAND

Matters arising from the last meeting

The Clerk reported that the web designer had been unable to determine the exact number of hits on the Bandstand webpage. A site visit had been undertaken by the Clerk, the Chairman and Mr Leathley together with the electrical contractor and an external socket had been installed with a heavy duty extension lead to ensure that safe access for electricity by users of the Bandstand could be provided. The Clerk had agreed a 50% reduction for the electrical works by way of sponsorship for the Bandstand by Maltby's Electrical Contractors. Repairs to the Bandstand base would be undertaken before Easter. The Clerk advised that an additional payment to the Band Concert Supervisor had been approved by the full council and letters to all sponsors of the Bandstand had been sent out as requested in early January. An estimate for shot blasting the structure of the Bandstand in the future would be sought prior to the next meeting. It was

The Chairman offered to approach both Filey Bay Traders and Filey Tourism Association members to try and increase sponsorship for the Bandstand. It was
