The Clerk confirmed that a letter of thanks had been sent to the Band Concert Supervisor. Cllr A Shaw suggested a Steel Band would be popular and the Clerk confirmed that enquiries had been made but the cost was prohibitive. Cllr Shaw stated that she had discussed the possibility of the café selling ice creams in Crescent Gardens during the Sunday Band Concerts due to some attendees not being able to access the slope to the café, but as yet no agreement had been reached with the proprietor.
