Bandstand Roof Repainting

The Clerk informed members that the contractor which had been appointed to repaint the Bandstand roof no longer wished to carry out the work due to being unable to meet the specifications required by the Town Council. The Clerk had sent out details to three different companies, no response received from one company, one company advising that the Bandstand Roof should not be repainted and one detailed quotation being received. After due consideration of the detailed quotation with an expectation being highlighted that the treatment should remain sound for ten years it was agreed to proceed with this work as soon as possible. The Clerk informed members of the balance of funds held in the Bandstand Reserve and the kind donation of £100 from the Filey Rotary Club towards this work. It was

RESOLVED: That a recommendation be made to full council that Frank Smith Decorators be awarded the contract to repaint the Filey Bandstand Roof as per the detailed quotation supplied at a cost of £1,162.00 plus VAT with funds being utilised from the Bandstand Reserve.
