DECLARATIONS OF INTEREST

The Chairman reminded members of the need to consider whether they needed to declare a disclosable pecuniary interest (DPI) or personal interest as detailed in Appendix A and Appendix B of the Town Council's Code of Conduct.

FILEY TOWN BUS SERVICE

Cllr Susan Bosomworth left the room for this agenda item after having declared a pecuniary interest. Members had previously been circulated with a letter from Mr C Galway, Olympic Coaches which gave detailed information regarding his accounts for year ending 5 April 2016. The Chairman invited Mr Galway to speak to members to give a progress update regarding the Filey Town Bus Service and he informed members of his investment in a new vehicle and answered questions from members regarding the service. Members thanked Mr Galway for operating this well-respected service which was well used by local residents and in particular older people in the town to access local shops, banks, post office, doctors etc. The RFO informed members that Scarborough Borough Council had not agreed not to make any contribution to the Filey Town Bus Service in 2017/2018. Members agreed to defer making a decision regarding any contribution towards the service in 2017/2018 until later in the meeting when the draft precept and draft budget would be considered. It was

RESOLVED: That Mr Galway be thanked for attending the meeting and the above information be noted and re-discussed later in the meeting. F043/017

BANK RECONCILIATIONS

FIXED TERM DEPOSIT ACCOUNTS

The RFO informed members that she had rolled over the Fixed Term Deposits for Santander at 0.5% and Lloyds Bank at 0.9% for a further 12 months. The RFO stated that she was finding difficulty in finding other banking institutions which were not affiliated to main banks and therefore could not afford the Town Council of the Financial Compensation Scheme guarantee of £75K. The RFO suggested that additional funds could be placed in the Town Council's Public Sector Deposit Fund account which provided easy access and was not tied up for any fixed term period. FILEY SPORTS PROVISION PROJECT

Donation towards a Coble Landing Beach Launching Attendant

Members of the Finance & General Purposes Committee were requested to consider funding for a Beach Launching Attendant for Coble Landing for an additional one month (weekends only) during the summer 2017. The Borough Council would fund an attendant for three months (weekends only) and had supplied an approximate cost of £700 for an additional month (weekends only). After discussion it was RESOLVED: That a recommendation be made to full council that a sum of £700.00 be earmarked in the Town Council's budget for 2017/2018 towards a donation for the cost of a Beach Launching Attendant for Coble Landing for one month (weekends only) in the summer 2017.

Donation towards the Filey Town Bus Service

Members were informed that Scarborough Borough Council had agreed that no further contribution would be made to the Filey Town Bus Service in 2017/2018 but were made aware that a local contribution of £2,500 had been agreed towards the Filey Town Bus Service. After consideration it was

RESOLVED: That a recommendation be made to full council that a financial contribution of £8,500 per annum for a period of one year with effect from 1 April 2017 be made to Olympic Coaches for the Filey Town Bus Service subject to a signed agreement with terms and conditions being agreed by the Town Council.

Draft Precept Requirement 2017/2018

Members discussed in detail the draft precept requirement for 2017/2018 in line with the draft budget for 2017/2018. The RFO circulated several calculations for precept requirements for member's consideration using the precept calculator as supplied by Scarborough Borough Council. It was noted that an additional 61 properties in Filey had been added to the property base and by applying no increase to last year's precept of £135,000 this automatically increased the current precept to £137,750 without making any increase to a Band D property council taxpayer. Members considered that it was necessary to increase the precept to £139,000 to accommodate the Town Council's planned budget to deliver the same level of quality services and to support the Filey Town Bus Service. It was noted that the slight increase in the precept would incur an additional 0.36p increase per annum to a Band D council tax payer. After due consideration it was
